Minutes of the October 30, 2017, Meeting 1300 Broadway, Room 1C, 9:00 a.m. Denver, Colorado

Present: Chairman Matt Smith; Vice-Chairwoman April Jones; Commissioner William Leone; Commissioner Gary Reiff; and Commissioner Jo Ann Sorensen.

Also Present: Dino Ioannides, IEC Executive Director; and Kyle Dumler and Gina Cannan of the Colorado Attorney General's Office.

I. GENERAL BUSINESS

- 1. Chairman Smith called the meeting to order at 9:05 a.m.
- 2. The Commission invited public comment and received none.
- 3. Upon motion duly seconded, the Commission unanimously approved the minutes of the September 28, 2017, meeting.
- 4. Mr. Ioannides provided the staff report.
- 5. Mr. Ioannides recused himself for the Commission's consideration of Complaint 16-13, Commissioner Leone presiding.

Upon motion duly seconded, the Commission unanimously approved issuance of the draft Notice of Issues for Hearing.
- 12. The Commission called Complaint 17-28. Commissioner Leone recused himself. Both the complainant and respondent appeared. By unanimous consent, Commissioner Sorensen will serve as the hearing officer for Complaint 17-28.
