# Minutes of the November 29, 2017, Meeting 1300 Broadway, Room 1C, 9:00 a.m. Denver, Colorado

Present: Chairman Matt Smith; Vice-Chairwoman April Jones; Commissioner William Leone; Commissioner Gary Reiff; and Commissioner Jo Ann Sorensen.

### I. GENERAL BUSINESS

- 1. Chairman Smith called the meeting to order at 9:12 a.m.
- 2. The Commission invited public comment and received same from one member of the public.
- 3. Upon motion duly seconded, the Commission unanimously approved the minutes of the October 30, 2017, meeting.
- 4. Mr. Ioannides provided the staff report.
- 5. The Commission called Complaint 17-18; Commissioner Jones presiding. The complainant and respondent's counsel were present.

- 33. Upon motion duly seconded, the Commission unanimously determined that there was no violation of Colo. Const. Art. XXIX in Complaint 16-20. The Commission ordered a draft written decision to be prepared.
- 34. Commissioner Reiff departed from the meeting.
- 35. Mr. Ioannides provided a status update regarding Complaint 17-28.

- 36. The Commission considered the motions for extension of time to file responses in Complaints 16-02 and 17-14. Mr. Ioannides recused himself. Upon motion duly seconded, the Commission unanimously (Commissioner Reiff not participating) granted the motion for extension of time to file responses in Complaints 16-02 and 17-14 to January 10, 2018.
- 37. Upon motion duly seconded, the Commission unanimously (Commissioner Reiff not participating) dismissed Complaint 17-42 as frivolous and for lack of jurisdiction under IEC Rules 7.G.1. and 7.G.2.
- 38. Upon motion duly seconded, the Commission unanimously (Commissioner Reiff not participating) dismissed Complaint 17-44 as frivolous under IEC Rule 7.G.1.
- 39. Upon motion duly seconded, the Commission unanimously (Commissioner Reiff not participating) dismissed Complaint 17-47 as frivolous under IEC Rule 7.G.1.
- 40. Mr. Ioannides provided a budget update regarding the FY19 budget.
- 41. At 3:47 p.m., upon motion duly seconded, the Commission voted unanimously to enter Executive Session pursuant to C.R.S. § 24-6-402(3)(a)(II) and §13-90-107(1)(b) concerning Legal Updates from the Office of the Attorney General, for purposes of receiving legal advice on specific legal questions.
