Minutes of the November 16, 2021, Meeting Meeting Conducted by Web Conference

I. GENERAL BUSINESS

- 1. Due to COVID-19, the meeting was conducted by web conference. The Chair being absent, Vice-chair Baschiera called the meeting to order at 9:01 a.m.
- 2. The Commission invited public comment and received none.
- 3. The Commission called Complaint 20-76. Complainant was present and Mr. Clint Smith entered his appearance on behalf of Respondent. The parties presented oral argument regarding the Commission's jurisdiction.
- 4. At 9:30 a.m., upon motion duly seconded, the Commission voted unanimously to enter closed session to discuss Complaint 20-76, for purposes of receiving legal advice.

- 11. Ms. Cannan provided the report of legal updates from the Office of the Attorney General. By unanimous consent, the Commission approved December 31, 2021, as the end of the public comment period for the Commission's rulemaking, with a rulemaking hearing to be held at the Commission's February, 2022, meeting.

At 9:58 a.m., upon motion duly seconded, the Commission voted unanimously to enter closed session to discuss Complaints 21-18, 21-23, and 21-24, for purposes of receiving legal advice and which are required to be kept confidential pursuant to Article XXIX, §5(3)(b) of the Colorado Constitution.
