### Minutes of the June 20, 2023, Meeting 1300 Broadway, Room 1E Denver, Colorado

### I. GENERAL BUSINESS

- 1. Chair Wist called the meeting to order at 9:08 a.m. (Commissioner Espinosa Krupa was not yet present).
- 2. The Commission invited public comment and received none.
- 3. The Commission unanimously approved the minutes of the April 18, 2023, meeting (Commissioners Thomas and Espinosa Krupa not participating).
- 4. Chair Wist welcomed Commissioner Thomas to the Commission.

- 10. The Commission called Complaint 23-02. By unanimous consent, the Commission instructed its staff to request that Respondent clarify the extent of its motion to dismiss or the grounds upon which it was filed and to set a deadline for the filing of Complainant's response.

At 9:40 a.m., upon motion duly seconded, the Commission voted unanimously to enter closed session to discuss Complaints 23-04, 23-10, and 23-11, for purposes of receiving legal advice and which are required to be kept confidential pursuant to Article XXIX, §5(3)(b) of the Colorado Constitution.

- 17. At 10:07 a.m., upon motion duly seconded, the Commission voted unanimously (Commissioner Mercer recused) to enter closed session for purposes of receiving legal advice regarding *Glendale v. IEC, Line v. IEC*, and Complaints 16-02 and 17-14.
- 18. Commissioner Mercer left the meeting at 10:07 a.m.
